Over-the-Counter COVID-19 Tests to be Covered

Effective January 15, 2022, in compliance with guidance issued as part of the Families First Coronavirus Response Act (FFCRA) and the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the Tenneco health plan will be covering over-the-counter (OTC) diagnostic COVID-19 tests for plan participants. Please note the following:

- ✓ This coverage is available through the Prescription Drug benefit portion of your coverage (administered by CVS Caremark), paying up to \$14 of the cost for specific OTC test costs (see table below) when you present your Tenneco Prescription Drug benefit card and purchase them at any National pharmacy (visit Caremark.com for a list of participating pharmacies or call the telephone number listed below). If a test is purchased outside of a National pharmacy, you may seek reimbursement by filing a claim with CVS Caremark.
- ✓ Coverage (in or out-of-network) is limited to 8 OTC tests per plan participant per month and includes only tests purchased for diagnostic purposes (not for employment purposes). If tests are purchased out-of-network or without showing your Tenneco Prescription Drug benefit card at an in-network pharmacy, reimbursement is limited to a maximum of \$12 per test.
